Ms. Vandecruze has extensive expertise in mergers and acquisitions and capital raisings, most notably she provided expert testimony on the valuation of Conseco during the largest bankruptcy in the history of the insurance industry. Ms. Vandecruze has provided IPO advisory in the largest public offerings of insurance companies, throughout her career, Ms. Vandecruze has executed over \$25 billion in M&A and financing transactions. Ms. Vandecruze brings a unique combination of C-suite experience in banking, M&A, capital markets and accounting.

Prior to joining Swiss Re, Ms. Vandecruze was a Vice President at Head & Company, the first global private equity firm specializing in the insurance industry from 1996 to 1999 and an Associate in the Financial Institutions Group at Merrill Lynch from 1994 to 1996. Ms. Vandecruze is a CPA who began her career as an auditor in public accounting with EY from 1985 to 1988 before joining Grant Thornton where she worked from 1988 to 1992 becoming a Vice President. Ms. Vandecruze earned an MBA in Finance from The Wharton School at the University of Pennsylvania where she currently serves on the Wharton Graduate Executive Board. Ms. Vandecruze holds a BBA in Accounting from Pace University. Ms. Vandecruze has served on the board of M Financial Group since 2015 where she is a member of the audit and wealth committees, and was recently appointed to the board of The Doctors Company where she is a member of the investment committee. Ms. Vandecruze is a licensed Certified Public Accounting in New York and is a member of the AICPA and the New York State Society of CPAs.
